## **It's Not You, But It's Not Me, Either**

This year I had the honor of being accepted to the AALL Leadership Academy, which took place October 28-29 in Oak Brook, Ill. Thirty-four of us gathered together and spent two days learning about the qualities of a good leader, our own communication styles and those with whom we work, and how we can “all just get along.”

Some of you may be surprised to learn, while others of you are certainly not, that I'm an expressive. Some of the characteristics of an expressive include: talkative, emotional, energetic and fast-paced (have you heard me talk?). So, yes, yes, yes and yes. 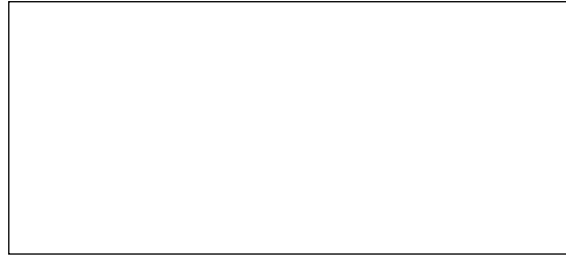
