

Locating Full-Text Articles in the Law Library and University Libraries' collection

Quick Guide


If you know the citation information for a particular article (author, article title, journal title, volume, and date), you can locate full-text articles in a few easy steps:

1. Go to the **CAT**, change the search perimeters to **"Journal Title"** and enter the journal publication title.
2. The resulting search will list how the title is available: print or electronically. *TIP: Be sure to scroll through the full list of results--the same journal may have multiple listings for each format OR similar journal titles maybe retrieved.*

3. If the journal is available *only in print*, you must either go to library (if it is local) to photocopy the material OR place an interlibrary loan request for the material. You can place the ILL request by going to: <https://ill.libraries.psu.edu/>

4. If the journal is available electronically, **[electronic resource]** will be present following the title. Click the  icon.

5. When the "Get It" window pops up, you will be presented with the databases that provide full-text access to that journal and the dates that coverage is available. Simply enter the volume/date information and click

IMPORTANT TIP:

Even if the journal is available electronically, it does not mean the coverage will meet your needs. For example, **The European Journal of Law** is available electronically from volume 3 to current but if you want an article from volume 1 or 2 you will need to check the CAT for its availability in print or submit an ILL request.
